Advanced Orthopedic Specialists Improves Efficiency Throughout Practice

Challenges

Another key feature is the system's ability to automatically update other chart sections (e.g., medications, problem list, medical history) as soon as the physicians complete a note in the EHR. The physicians save all notes electronically, eliminating the need for transcription and saving the practice time and money.
